Have you completed a **business continuity plan** to gather the most important information in a short document for purposes of emergency?






So you need a business continuity plan

- Short nobody uses a big document in an emergency
- Core elements only
 - How to contact team
 - Where to meet as a team
 - Where and how to provide your services
 - Action plan for recovery
 - Important contacts
 - Critical data protection and recovery
 - Hard-copy data and equipment
